

# **2023 Statistics - Disabilities in New Jersey**

## Prevalence

- About 1 in 4 adults in New Jersey have a disability.
- Since 2011 in NJ, the percentage of people with an independent living disability has stayed steady, meaning demand for independent living services has also stayed steady.
- By county, both Gloucester (6.3%) and Camden (7.9%) counties have higher rates of people with independent living difficulties than the state average (2021)
- Recommendations: More investment and support for independent living services and organizations could help the challenges this community faces. In addition, funding for outreach to these communities is important to spread awareness about available programs and services.







# Employment

- In 2021, 24.2% of people with disabilities were employed in New Jersey compared to 61% of people without disabilities.
- Over the past decade employment status has remained relatively stable for people with disabilities in New Jersey. The gap between people with and without disabilities remains, with those with disabilities seeing a marginal increase over time.
- **RECOMMENDATIONS:** More investment in employment programs, training, and opportunities to address the gap and keep the data trending in the right direction.







#### Income

- Since 2011, income for both people with and without disabilities in New Jersey has risen, but the significant income gap remains. Income for people without disabilities has risen at a greater rate than those with disabilities.
- Both Gloucester and Camden counties have lower median incomes than the state average for people with disabilities
- **RECOMMENDATIONS:** Income is largely tied to jobs and social service supports. A more intentional focus on these areas may help address this income gap.

#### CILSJ Region - Percent Commuting to Work via Public Transit (2021)



# **Public Transportation**

- In recent years, there has been a dramatic decline in the percentage of commuters using public transit to get to work for both people with and without disabilities.
- Until 2015, people with disabilities used public transit for work at higher rates than those without disabilities, with a historic high of 13.3% in 2012.
- Both Gloucester and Camden counties have lower rates than the state average for people with and without disabilities
- **RECOMMENDATIONS:** First, it is important to better understand what mechanisms are behind this recent dip. Access and accessibility are also important areas of concern when it comes to encouraging people with disabilities to utilize public transportation for work.



## Education

- Since 2011 in New Jersey, all groups experienced a decline in "less than high school" educational attainment. At the same time, all groups also experienced a rise in rates of higher education (BA degree or higher). While these data are promising, gaps between those with and without disabilities are persistent.
- With respect to higher education rates, both Goucester and Camden counties are below the state average for people with disabilities.
- RECOMMENDATIONS: Invest and support more education opportunities for people with disabilities, including training programs and school to career pipelines connected with industry. Additionally, preparing people with disabilities in New Jersey for the future landscape of jobs will be important given the significance of automation and other technological advances coming in the next decade.



## Poverty Status in New Jersey (2011 to 2021)

## **Poverty Status**

- Since 2011 in New Jersey, the percent of people with and without disabilities who are living 100% below the poverty level has remained steady with little change over the past decade. In addition, the gap between those with and without disabilities has also remained steady.
- The poverty rate for people with disabilities in Gloucester County (13.5%) is lower than the state average (17.1%), while Camden County is higher at 19.7%.
- **RECOMMENDATIONS:** Invest in more social services and support for people with disabilities. In addition, creating and supporting programs that address immediate needs like food banks, rental assistance, and other support services.

With the exception of 2020, when only the 5-year file is accessible, all data sources employ ACS 1-Year files. However, for particular economic statistics pertaining to Gloucester County, solely the 5-Year file was accessible. Each table and graph specifies the sources used.
